PUBLIC MEETING NOTICE

The Academic Quality and Student Success Committee of the Board of Trustees of the Oregon Institute of Technology will meet on February 22, 2015 at 8:00am. Agenda items include approval of the October 8, 2015 committee minutes, an update on program approval, a presentation on textbook costs, and a joint presentation on on-line education, extension programs, and the STEM Hub program.

The Finance and Facilities Committee of the Board will meet on February 22, 2016 at 10:15am. Agenda items include approval of the February 2, 2016 committee minutes; consideration of making recommendations to the Board regarding approval of a one-time funding philosophy, adoption of a debt policy, adoption of a tuition and fee policy, and approval of the capital budget of the Soccer Field project; a discussion on the creation of an investment policy and an endowment policy; an investment update; and a presentation on the June 30, 2015 Annual Financial Report.

The Executive Committee will meet on February 22, 2015 at 1:30pm. Agenda items include approval of the October 8, 2015 committee minutes, consideration of making a recommendation to the Board to authorize the university president to enter into an agreement to exchange services and support with the Oregon Tech Foundation, recommendation of a candidate for the vacant Trustee position, and a report from the AVP of Marketing.

The Board of Trustees will meet on February 22 at 3:00pm and on February 23 at 8:00am. Agenda items include reports from the President, Faculty Senate, ASOIT, Administrative Council, AVP of Development and Alumni Relations, AVP of Government Relations, and committee chairs; approval of minutes from the December 15, 2015 meeting and a one-time funding philosophy; adoption of an operating budget fund balance policy, a debt policy, and a tuition and fee policy; authorization to enter into an agreement with the Oregon Tech Foundation; renewal of a values statement; presentations on the fiscal year 2015 audit, dashboard creation and strategic plan updates, economic impact report, and sponsored opportunities; consideration of approval of the capital budget for the design and construction of the soccer field project; and discussions regarding communication protocol and the creation of a presidential evaluation policy.

The Board will hold an Executive Session per ORS 192.660(2)(a) and (i) at 1:45pm on February 23. The Board will consider the employment of public officers, employees, and agents; and review and evaluate performance of public officers and employees. This meeting is closed to the public.
